1 Before the Court is the parties' Joint Stipulation to Stay Litigation. The
2 parties have agreed to stay the above-captioned actions in light of the outstanding

5 IT IS HEREBY ORDERED, ADJUDGED, AND DECREED THAT:

- 6 1. The parties' Joint Stipulation to Stay Litigation is GRANTED; and
7 2. The above-captioned actions are STAYED removed from the active
8 caseload.
9 3. The parties are ORDERED to file a Joint Status Report every 60 days
10 regarding the status of the above petitions for *inter partes* review or within 10 days
11 of (1) a determination by the PTAB whether to institute any additional petitions; or
12 (2) the issuance of a Final Written Decision by the PTAB for any instituted requests
13 for *inter partes* review, whichever is earlier.
