Pursuant to the Court's directive (Dkt. 282), Plaintiffs NantWorks LLC and Nant Holdings IP, LLC ("NantWorks") and Defendants Bank of America Corporation and Bank of America, N.A. ("Bank of America") jointly submit this status report in advance of the post-mediation status conference on November 9, 2023.

The parties participated in in-person mediation with the Honorable Layn R. Phillips (ret.) in Corona Del Mar, California on October 31, 2023. The parties were unable to reach an agreement.

Additional Update from Defendants

The Parties are continuing to work toward completing all remaining depositions, which due to conflicts are now anticipated to be complete by the end of November, which is after the close of fact discovery.

Defendants are also still waiting for additional/supplemental discovery from Plaintiffs relating to Plaintiffs' alleged trade secrets (and pursuant to this Court's order), as well as relating to Google Analytics.

Additional Update from Plaintiffs

In addition to dates for the remaining depositions, Plaintiffs are also waiting for witness designations from Defendants for numerous topics pursuant to Plaintiffs' Rule 30(b)(6) deposition notice. Additionally, Defendants have yet to produce relevant source code that Plaintiffs have requested. Given these outstanding issues, an extension to the current case schedule may be necessary.
