1 The parties to this action hereby request that the Court continue for two
2 weeks the hearing for Defendant's Partial Motion to Dismiss and the date for
3 Defendant to file its corresponding Reply Brief.

4 Defendant Hikvision filed a Notice of Motion and Partial Motion to Dismiss
5 Under Federal Rule of Civil Procedure 12(b)(6). Dkt. 27. The hearing on

13 allow the parties to spend time drafting a settlement agreement. *See* Declaration of
