Ltd. (collectively, the "Ubisoft and Square Enix Defendants"), requests that she be allowed to appear telephonically at the upcoming scheduling conference and hearing scheduled for December 21, 2020. Good cause exists to support counsel's motion.

Defendants' lead counsel is located in Overland Park, Kansas, and to attend the hearing in person will require both air travel and an overnight stay.
