1 Pursuant to the Court's June 15, 2016 Order Staying Action (Dkt. 205), Plaintiff Core
2 Wireless Licensing, S.a.r.l. ("Core Wireless") and Defendant Apple Inc. ("Apple") submit this
3 joint status report.

4 On June 15, 2016, the Court stayed this case "in its entirety pending the IPR
5 proceedings." *Id.* The status of these IPR proceedings is summarized below:

- 6 1. U.S. Patent No. 7,693,552 (IPR2015-01902): Core Wireless filed its Response to
7 Petition on May 4, 2016. Apple filed its Reply on July 22, 2016. Oral argument was
8 held October 4, 2016.
- 9 2. U.S. Patent No. 8,498,671 (IPR2015-01983): Core Wireless filed its Response to
10 Petition on June 2, 2016. Petitioner (LG Electronics, Inc.) filed its Reply on
11 September 2, 2016. Oral argument is presently scheduled for November 30, 2016.
- 12 3. U.S. Patent No. 8,434,020: Core Wireless filed its Response to LG Electronics, Inc.'s
13 Petition (IPR2015-01984) on June 30, 2016. LG Electronics, Inc. filed its Reply on
14 September 30, 2016. Core Wireless filed its Response to Apple's Petition (IPR2015-
15 01898) on July 15, 2016. Apple's Reply is due October 17, 2016.
- 16 4. U.S. Patent No. 8,713,476: Core Wireless filed its Response to LG Electronics, Inc.'s
17 Petition (IPR2015-01985) on June 30, 2016. LG Electronics, Inc. filed its Reply on
18 September 30, 2016. Core Wireless filed its Response to Apple's Petition (IPR2015-
19 01899) on July 15, 2016. Apple's Reply is due October 17, 2016.
