

18	Plaintiff Apple Inc. ("Apple") and defendant Mobile Star, LLC ("Mobile Star") (Apple		
19	and Mobile Star collectively "the Parties"), by and through their respective counsel, hereby		
20	stipulate as follows:		
21	WHEREAS the Parties held an ADR telephone conference with the Court's ADR staff or		
22	February 16, 2017, during which they discussed ADR options;		
23	WHEREAS, the Parties desire to use a private ADR mediation service, such as JAMS, to		
24	try to resolve their dispute rather than the services of the Court's ADR office;		
25	WHEREAS, the Parties agree to select a mediator who is mutually agreeable to each of		
26	the Parties;		
27	WHEREAS, the Parties agree to hold the mediation in the San Francisco Bay Area;		
28	WHEREAS, Mobile Star believes that the Parties should complete mediation within 60		



days of the Case Management Conference, and has requested that the Court stay discovery for 60 days to allow the Parties to complete mediation without incurring the expense of additional discovery;

WHEREAS, Apple opposes the request for a stay because it believes it needs additional discovery to engage in settlement discussions, to prosecute its case against Mobile Star, and to determine whether and which third-parties should be named as defendants, and believes that the Parties should work in good faith to complete mediation within 90 days of the Case Management Conference.

Now, therefore, the Parties, through their respective counsel, stipulate as follows:

- 1. The Parties will use a private mediation service, such as JAMS, to mediate their dispute, rather than the services of the Court's ADR office;
 - 2. The Parties will select a mediator who is mutually agreeable to each of the Parties;
 - 3. The Parties will hold the mediation in the San Francisco Bay Area;
- 4. The Parties will work in good faith to complete the mediation either within 60 or 90 days of the Case Management Conference, depending on the Court's order.
