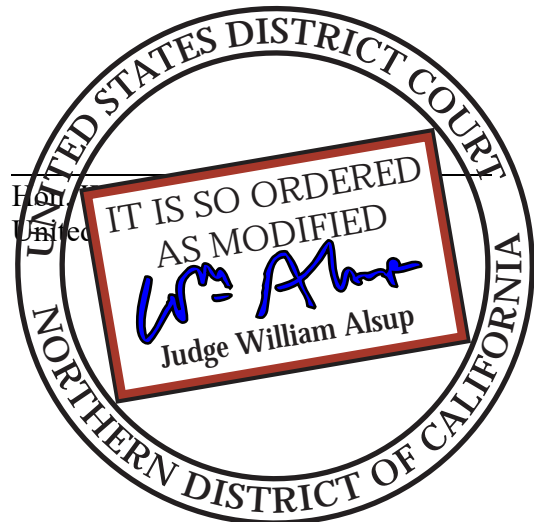
1 This matter came before the Court on Juniper Networks, Inc.'s ("Juniper") December 5,  
2 2018 Administrative Motion Regarding Courtroom Equipment for Trial (the "Motion"). Juniper
