24 In *Arctic Cat Inc. v. Bombardier Recreational Products*, 876 F.3d 1350, 1368 (Fed. Cir.  
 25 2017), the Federal Circuit held that an alleged infringer may meet its burden of production with  
 26 respect to a marking defense by “putting the patentee on notice that he or his authorized licensees  
 27 sold specific unmarked products which the alleged infringer believes practice the patent.”  
 28 Defendant Juniper Networks, Inc. (“Juniper”) hereby puts Plaintiff Finjan, Inc. (“Finjan”) on

1 notice that Juniper contends that the following Finjan and licensee products are “patented articles”  
2 for which Finjan has the burden of proving compliance with 35 U.S.C. § 287. Juniper notes that,  
3 for some of the licensees, Juniper is unable to identify specific products at this time because Finjan  
4 has not provided a complete production of documents related to its licenses and negotiations with  
5 third parties. Juniper intends to supplement this notice when Finjan complies with its discovery  
6 obligations.
