Finjan's Motion to Seal portions of this Court's *Daubert* Order of December 3, 2018 (Dkt. 283) was brought before this Court. Upon consideration of the motion and the supporting papers, the Court finds that compelling reasons exist to grant the motion. Specifically, the Court finds that:

1. The interest of Finjan and its third-party licensees in maintaining confidentiality of the specific lines of material recited below outweighs the right of public access to said material:

- 2. A substantial probability exists that the confidentiality interests of Finjan and its thirdparty licensees will be prejudiced if the specific lines of material above are not sealed; and
 - 3. No less restrictive means exist to protect the interests of Finjan and its licensees.

IT IS THEREFORE ORDERED that Finjan's Motion to Seal be, and hereby is, GRANTED with respect to the specific lines of material set forth above.
