Plaintiff Finjan, Inc.'s ("Finjan") Administrative Motion to File Documents Under Seal was brought before this Court. Upon consideration of this motion and the supporting declaration of Kristopher Kastens filed in support of the motion, the Court finds there to be good cause and compelling reasons for granting the request to file certain documents under seal.

Compelling reasons having been shown, the Court finds that:

1. There exist overriding confidentiality interests that have overcome the right of public access to the record of the following documents:

- 4. No less restrictive means exist to achieve these overriding interests.
