1 Defendant Qualys Inc.'s ("Qualys") Renewed Administrative Motion to File Documents
 2 Under Seal was brought before this Court. Upon consideration of this motion and the supporting
 3 declaration of Christopher Mays filed in support thereof, the Court finds there to be good cause
 4 and compelling reasons for granting the request to file certain documents under seal.

5 GOOD CAUSE and compelling reasons having been shown, the Court finds that:

6 1. There exists overriding confidentiality interests that overcome the right of public
 7 access to the record of the following documents:



 15 2. A substantial probability exists that the overriding confidentiality interests will be
 16 prejudiced if the record is not sealed;

17 3. The proposed sealing is narrowly tailored; and

18 4. No less restrictive means exist to achieve these overriding interests.

 20 IT IS THEREFORE ORDERED that Qualys's Renewed Administrative Motion to File
 21 Documents Under Seal is GRANTED with respect to the documents set forth above.
