**[PROPOSED] ORDER GRANTING**  
**FINJAN, INC.'S**  
**ADMINISTRATIVE MOTION TO**  
**FILE UNDER SEAL**

1 Plaintiff Finjan, Inc.’s Administrative Motion to File Under Seal was brought  
 2 before this Court. Upon consideration of this motion and the supporting declaration  
 3 of Robert Courtney filed in support of the motion, the Court finds that good cause  
 4 exists for sealing certain documents.

5 Good cause having been shown, the Court finds that there exist overriding  
 6 confidentiality interests that overcome the right of public access to the record for the  
 7 subject documents as follows:

16 The Court also finds that a substantial probability exists that the overriding  
 17 confidentiality interests will be prejudiced absent sealing, the sealing is narrowly  
 18 tailored, and no less restrictive means exist to achieve these overriding interests.

19 IT IS THEREFORE ORDERED that Finjan’s Administrative Motion to File  
 20 Under Seal be, and hereby is, GRANTED with respect to the documents as set forth  
 21 above.
