6 Pursuant to Civil Local Rule 3-15, Qualys believes that Finjan's Amended Certification
7 of Interested Parties or Persons (Dkt. No. 117) is incomplete and should identify two publicly
8 traded companies, Fortress Investment Group LLC (NYSE:FIG) ("Fortress") and SoftBank
9 Group Corp. (NYSE:SBG) ("SoftBank").
