1 Plaintiff Finjan LLC's ("Finjan") Administrative Motion to File Under Seal was brought
 2 before this Court. Upon consideration of this motion and supporting declaration of Christopher
 3 Mays filed in support thereof, the Court finds there to be good cause and compelling reasons for
 4 granting the request to file certain documents under seal.

5 GOOD CAUSE and compelling reasons have been shown, the Court finds that:

6 1. There exists overriding confidentiality interests that overcome the right of public access
 7 to the record of the following portions of the following documents:
