1 compliance deadline on Wednesday, April 10, 2024 is intended to confirm that counsel have
2 reviewed the Court's Pretrial Setting Instructions and are in compliance therewith. Five (5)
3 business days prior to the date of the compliance deadline, the parties shall file a one-page JOINT
4 STATEMENT confirming they have complied with this requirement or explaining their failure to
5 comply. If compliance is complete, the parties need not appear and the compliance deadline will
6 be taken off calendar. Telephonic appearances will be allowed if the parties have submitted a joint
7 statement in a timely fashion. Failure to do so may result in sanctions.

8 The parties must comply with both the Court's Standing Order in Civil Cases and Standing
9 Order for Pretrial Instructions in Civil Cases for additional deadlines and procedures. All
