Pursuant to Civil L.R. 6-2 and 7-12, Plaintiff Yahoo! Inc. ("Yahoo") and Defendants Kudelski SA and OpenTV, Inc. 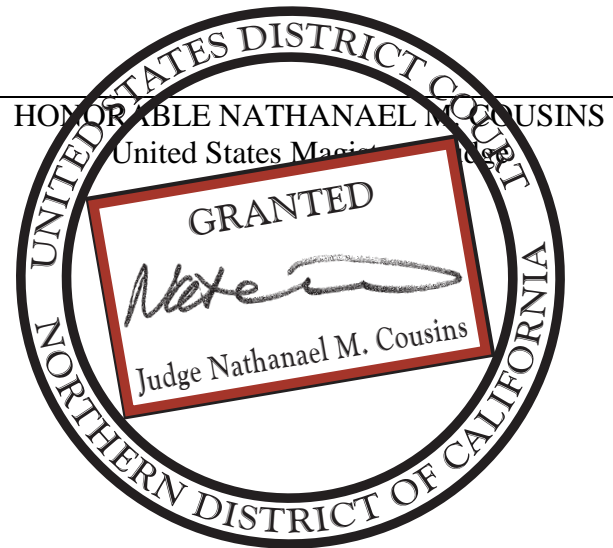
