1. A substantial probability exists that the overriding confidentiality interests will be prejudiced if the record is not sealed;

2. The proposed sealing is narrowly tailored; and

3. No less restrictive means exist to achieve these overriding interests.

IT IS THEREFORE ORDERED that Finjan's Administrative Motion to File Documents Under Seal is GRANTED with respect to the documents set forth above.
