1                   **JOINT MOTION AND [PROPOSED] ORDER TO STAY ALL DEADLINES**

2                   Pursuant to Civil Local Rule 7-12, the Court on September 30, 2019, entered a stay of all  
3 deadlines pertaining to Plaintiff ZTE (USA) Inc. (“ZTE”) and Defendant AGIS Software  
4 Development LLC (“AGIS Software”) (collectively, the “Parties”). Dkt. No. 120. The Parties  
5 hereby further stipulate and agree as follows:

6                   **IT IS HEREBY STIPULATED AND AGREED**, by and between Plaintiff and  
7 Defendant, through their respective undersigned counsel, that all matters in controversy between  
8 the Parties are settled in principle. The Parties respectfully request that this Court further  
9 continue the stay of all case deadlines between the Parties for an additional seven (7) days, until  
10 and including November 6, 2019. The Parties have finalized the agreement but need additional  
11 time to execute the agreement and to file appropriate documents with the Court. Good cause  
12 exists for the extension due to the Parties’ schedules and foreign-located representatives  
13 requiring additional time to execute the settlement documents without involving the Court.
