1 Amazon.com, Inc. and Amazon Web Services, Inc. (collectively, “Amazon”) and
2 PersonalWeb Technologies, LLC and Level 3 Communications, LLC (collectively,
3 “PersonalWeb”) hereby stipulate and recite as follows:

4 WHEREAS, on January 9, 2019, PersonalWeb filed its Opposition to Amazon’s Motion for
5 Summary Judgment on Declaratory Judgment Claims and Defenses Under the Claim Preclusion
6 and Kessler Doctrine (No. 18-md-2834, Dkt. 334) and the Declaration of Wesley Monroe in support
7 thereof (No. 18-md-2834, Dkt. 340) (collectively, the “Opposition”);

8 WHEREAS PersonalWeb’s Opposition references or includes certain information
9 designated by Amazon as confidential under the Protective Order (No. 18-md-2834, Dkt. 290) (the
10 “designated material”);

11 WHEREAS, in connection with its Opposition, PersonalWeb filed an Administrative
12 Motion to File Under Seal (No. 18-md-2834, Dkt. 341) portions of the Opposition referring to or
13 reflecting the designated material (the “Sealing Motion”);

14 WHEREAS, under Local Rule 79-5(e)(1), within four days of filing of the Sealing Motion,
15 or by January 14, 2019, Amazon is required to submit a responsive declaration establishing that the
16 designated material is sealable;

17 WHEREAS, Amazon has requested and PersonalWeb has agreed to a one-week extension,
18 until January 21, 2019, of the deadline for Amazon to file its response to the Sealing Motion;

19 WHEREAS, the requested extension will not alter the date of any event or any deadline
20 already fixed by Court order;

21 **IT IS HEREBY STIPULATED AND AGREED** by the parties as follows:

22 Amazon’s deadline to submit its response to the Sealing Motion pursuant to Local Rule 79-
23 5 shall be extended up to and until January 21, 2019.
