1 PersonalWeb Technologies, LLC (“PersonalWeb”), Level 3 Communications, LLC (“Level
2 3”), and Amazon.com, Inc. and Amazon Web Services, Inc. (collectively “Amazon”) hereby stipulate
3 and recite as follows:

4 WHEREAS, on April 24, 2019, Amazon filed the Motion for Judgment on the Pleadings on
5 Infringement Claims Against CloudFront (No. 18-md-2834, Dkt. 413) and associated Request for
6 Judicial Notice re Motion for Judgment on the Pleadings on Infringement Claims Against CloudFront
7 (No. 18-md-2834, Dkt. 414) (collectively, the “Motion”);

8 WHEREAS, pursuant to the Local Rules, PersonalWeb’s Opposition and supporting papers to
9 the Motion are due May 8, 2019, and Amazon’s Reply and supporting papers are due May 15, 2019;

10 WHEREAS, Amazon’s Motion is set for hearing on October 3, 2019;

11 WHEREAS, in light of upcoming deadlines in this case, the parties have conferred and agreed
12 to a two-week extension, until May 22, 2019, of PersonalWeb’s deadline to file its Opposition to the
13 Motion, and a corresponding two-week extension, until June 12, 2019, of Amazon’s deadline to file
14 its Reply to PersonalWeb’s opposition;

15 WHEREAS, the requested extensions will not alter the date of any event or any deadline
16 already fixed by Court order;

17 **IT IS HEREBY STIPULATED AND AGREED** by the parties as follows:

18 The deadline for PersonalWeb to file its Opposition and supporting papers to the Motion shall
19 be extended up to and until May 22, 2019 and the deadline for Amazon to file its Reply to
20 PersonalWeb’s Opposition shall be extended up to and until June 12, 2019.
