[PROPOSED ORDER]

Having considered the joint statement on the motion by Amazon.com, Inc. and Amazon Web Services, Inc. (“Amazon”) to compel PersonalWeb to provide interrogatory responses and produce documents, IT IS HEREBY ORDERED THAT all relief requested by Amazon.com, Inc. and Amazon Web Services, Inc. (collectively “Amazon”) in the joint statement is hereby **GRANTED**, and the Court hereby **ORDERS** as follows:

- (1) PersonalWeb shall respond fully to Amazon’s Interrogatory Nos. 11-14 by providing a complete narrative response, including identifying all responsive contentions and supporting facts, within seven (7) days of this order;
- (2) PersonalWeb shall produce all documents responsive to Amazon’s RFP Nos. 94 and 95 within seven (7) days of this order;
- (3) To the extent it maintains any claim of common interest privilege with respect to any documents responsive to RFP Nos. 94-95, PersonalWeb shall provide a log of all withheld documents with a description of its basis for assertion of the privilege within fourteen (14) days of this order;
- (4) Amazon shall raise any issues regarding compliance with this order within thirty (30) days.
