1 PersonalWeb Technologies, LLC (“PersonalWeb”), and Amazon.com, Inc. and Amazon  
2 Web Services, Inc. (collectively, “Amazon”) and Twitch Interactive, Inc. (“Twitch”) stipulate as  
3 follows:

4 WHEREAS, per the Court’s October 6, 2020 order granting Amazon and Twitch’s motion  
5 for attorneys’ fees and bill of costs (collectively, the “Motion”), PersonalWeb had two weeks from  
6 the date of the Court’s order, through October 20, 2020, to file a supplemental brief to address the  
7 reasonableness of the fees requested in the Motion, and Amazon and Twitch had one week after  
8 PersonalWeb’s submission to file a reply, through October 27, 2020 (Dkt. 636);

9 WHEREAS, due to the complexity of the issues and substantial fee request, the parties have  
10 conferred and agree that PersonalWeb shall have up until October 30, 2020 to file its supplemental  
11 brief, and Amazon and Twitch shall have up until November 16, 2020 to file its reply;

12 BASED ON THE FOREGOING, THE PARTIES HEREBY STIPULATE as follows:

- 13 1. PersonalWeb shall have up until October 30, 2020 to file its supplemental brief; and
- 14 2. Amazon and Twitch shall have up until November 16, 2020 to file its reply.
