1 Amazon.com, Inc. and Amazon Web Services, Inc. (collectively, “Amazon”), Twitch
2 Interactive, Inc. (“Twitch”), and PersonalWeb Technologies, LLC (“PersonalWeb”) stipulate as
3 follows:

4 WHEREAS, on October 6, 2020, the Court ordered the parties to submit a joint statement
5 by October 20, 2020 stating their respective positions as to how the Court should enter its Summary
6 Judgment Order finding non-infringement (Dkt. 578) and final judgment in all remaining customer
7 cases in the MDL (Dkt. 637); and

8 WHEREAS, Amazon, Twitch and PersonalWeb continue to work on the joint statement
9 requested by the Court and seek a one-week extension of the October 20, 2020 deadline, until
10 October 27, 2020, to coordinate with counsel for customer defendants not represented by Fenwick
11 & West LLP;

12 BASED ON THE FOREGOING, THE PARTIES HEREBY STIPULATE that the parties
13 to the MDL action shall have until October 27, 2020 to file a joint statement stating their respective
14 positions as to how the Court should enter its Summary Judgment Order finding non-infringement
15 (Dkt. 578) and final judgment in all remaining customer cases in the MDL.
