1 Stubbs Alderton & Markiles, LLP (collectively, “SAM”) has moved to withdraw as counsel
2 of record for PersonalWeb Technologies, LLC (“PersonalWeb”) in the above-captioned litigation and
3 related post judgment proceedings pursuant to Civil Local Rule 11-5(a) and California Rules of
4 Professional Conduct, Rule 1.16(a)(2) because (1) there has been a irremediable breakdown in the
5 relationship between SAM and PersonalWeb, (2) SAM cannot render competent legal services to
6 PersonalWeb in the post judgment proceedings, and (3) there is an actual, adverse, and irreconcilable
7 conflict of interest between SAM and PersonalWeb.

8 Based upon the Court’s review of the evidence submitted and after oral argument of counsel,
9 the Court finds that SAM has submitted satisfactory bases that requires it to withdraw as counsel for
10 PersonalWeb and therefore it is hereby ordered that the Motion to Withdraw as Counsel for
11 PersonalWeb filed by SAM is granted effective immediately.
