[PROPOSED] ORDER

Before this Court is the Joint Statement of Amazon.com, Inc., Amazon Web Services, Inc., Twitch Interactive, Inc. (collectively, "Amazon") and third-parties Brilliant Digital Entertainment, Inc., Europlay Capital Advisors, LLC, and Claria Innovations, LLC (collectively, "PersonalWeb Affiliates").
