1 WHEREAS, Plaintiff PersonalWeb Technologies, LLC (“PersonalWeb”) has accused  
2 Defendants Amazon.com, Inc., Amazon Web Services, Inc., and Twitch Interactive, Inc.  
3 (collectively, “Amazon”) (collectively, PersonalWeb and Amazon may be referred to as “Parties”)  
4 of infringing, inter alia, U.S. Patent Nos. 7,802,310 (“’310 Patent”) and 6,928,442 (“’442 Patent”);

5 WHEREAS, the current deadline for Amazon to file a request for supplemental fees  
6 (including for fees pursuant to 35 U.S.C. § 285; the appeal fees denied without prejudice by the  
7 Court in its April 19, 2021 Order (Dkt. 656); and fees that Amazon has incurred since) (“Fees  
8 Submission”) is June 9, 2022 (Dkt. 732);

9 WHEREAS, on February 10, 2022, Stubbs, Alderton & Markiles, LLP (“Stubbs Alderton”),  
10 counsel for PersonalWeb, moved to withdraw from the action with a hearing on that motion  
11 scheduled for June 23, 2022 (Dkt. 728);

12 WHEREAS, the Parties jointly agree that the time for Amazon to file its Fees Submission  
13 should be extended in the interest of first clarifying whether Stubbs Alderton will continue to  
14 represent PersonalWeb and oppose the Fees Submission on its behalf, or to possibly allow  
15 PersonalWeb an opportunity to retain substitute counsel and provide such counsel sufficient time  
16 to get up to speed on the issues in the case, review the Fees Submission, and file a response on  
17 behalf of PersonalWeb;

18 NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED amongst the Parties  
19 that that the deadline for Amazon to file its Fees Submission before this Court be extended from  
20 June 9, 2022 until September 30, 2022.
