1 WHEREAS, Plaintiff PersonalWeb Technologies, LLC (“PersonalWeb”) has accused  
2 Defendants Amazon.com, Inc., Amazon Web Services, Inc., and Twitch Interactive, Inc.  
3 (collectively, “Amazon”) (collectively, PersonalWeb and Amazon may be referred to as “Parties”)  
4 of infringing, inter alia, U.S. Patent Nos. 7,802,310 and 6,928,442;

5 WHEREAS, the current deadline for Amazon to file a request for supplemental fees  
6 (including for fees pursuant to 35 U.S.C. § 285; the appeal fees denied without prejudice by the  
7 Court in its April 19, 2021 Order (Dkt. 656); and fees that Amazon has incurred since) (“Fees  
8 Submission”) is September 30, 2022 (Dkt. 743);

9 WHEREAS, the Parties have an ongoing dispute regarding whether Stubbs, Alderton &  
10 Markiles, LLP, counsel for PersonalWeb, may withdraw from this action and whether Lewis Roca  
11 Rothgerber Christie LLP, new counsel for PersonalWeb, has entered a notice of appearance in this  
12 case sufficient to meet the Court’s requirements for substitute counsel, and the Court has scheduled  
13 a case management conference to address this issue for September 29, 2022;

14 WHEREAS, Amazon has filed two motions to compel related to the Fees Submission that  
15 remain pending before the Court (Dkts. 771 & 773);

16 WHEREAS, Amazon desires to make one final supplemental fees submission rather than  
17 serial requests for supplemental fees;

18 WHEREAS, the Parties jointly agree that the time for Amazon to file its Fees Submission  
19 shall be extended to allow additional time: (i) to clarify who will be representing PersonalWeb on  
20 the Fees Submission and going forward in the case before any response to the Fees Submission  
21 becomes due, (ii) to resolve the pending motions to compel and for the parties to comply with any  
22 orders therefrom, and (iii) for Amazon to make one final supplemental fees submission rather than  
23 serial requests for supplemental fees;

24 NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED amongst the Parties  
25 that that the deadline for Amazon to file its Fees Submission before this Court be extended from  
26 September 30, 2022 until January 15, 2023.
