1 WHEREAS, Robert M. Charles, Jr. and Patrick Emerson McCormick of Lewis Roca
2 Rothgerber Christie LLP (“Lewis Roca”) have agreed to represent Plaintiff PersonalWeb
3 Technologies, LLC (“PersonalWeb”) regarding post-judgment discovery, potential remand of the
4 fee award from the Federal Circuit, and collection efforts against PersonalWeb,

5 WHEREAS, the Parties agree that such scope of representation encompasses the
6 reasonably foreseeable tasks in these cases concerning PersonalWeb’s defense against Defendants
7 Amazon.com, Inc. and Twitch Interactive, Inc.’s (“Amazon”) enforcement of their judgment
8 against PersonalWeb;

9 WHEREAS, Lewis Roca represents that it is not authorized to, and will not, represent
10 PersonalWeb concerning any assertion of claims of patent infringement or related affirmative
11 defenses; and

12 WHEREAS, the Parties have pending discovery disputes, including whether PersonalWeb
13 must search its records in the possession of its former counsel Stubbs Alderton Markiles LLP in
14 responding to the Court’s discovery orders, and whether the Court should order any relief directly
15 against Stubbs Alderton Markiles, neither of which will be affected by the current stipulation (i.e.,
16 PersonalWeb and Amazon will not be deemed to have waived any right to relief by entering into
17 this Stipulation);

18 THE PARTIES THEREFORE AGREE THAT:

19 PersonalWeb has substantially complied with the Court’s past orders (Dkts. 760 & 769)
20 such that Stubbs Alderton Markiles should be permitted to withdraw as counsel of record for
21 PersonalWeb, with Lewis Roca continuing on as counsel of record according to the limitations set
22 forth above and stated in its Amended Notice of Appearance, Dkt. 770; and

23 The case management conference currently set for September 29, 2022 at the Parties’
24 request, per Dkt. 774, can be vacated.
