1 WHEREAS, Plaintiff PersonalWeb Technologies, LLC (“PersonalWeb”) has accused
2 Defendants Amazon.com, Inc., Amazon Web Services, Inc., and Twitch Interactive, Inc.
3 (collectively, “Amazon”) (collectively, PersonalWeb and Amazon may be referred to as “Parties”)
4 of infringing, inter alia, U.S. Patent Nos. 7,802,310 and 6,928,442;

5 WHEREAS, the current deadline for Amazon to file a request for supplemental fees
6 (including for fees pursuant to 35 U.S.C. § 285; the appeal fees denied without prejudice by the
7 Court in its April 19, 2021 Order (Dkt. 656); and fees that Amazon has incurred since) (“Fees
8 Submission”) is January 15, 2023 (Dkt. 777);

9 WHEREAS, on November 9, 2022, Magistrate Judge van Keulen ordered PersonalWeb to
10 produce the documents as ordered in Dkt. 793 to proceed on a rolling basis and be completed by
11 January 20, 2023, and further ordered that “[i]n light of the foregoing schedule, PersonalWeb and
12 Amazon are to meet and confer on a stipulation for an extension of the deadline for Amazon to file
13 its final supplemental attorney’s fees submission and submit the stipulation for Judge Freeman’s
14 consideration by November 18, 2023” (Dkt. 799);

15 WHEREAS, the Parties jointly agree that the time for Amazon to file its Fees Submission
16 should be extended to enable PersonalWeb to comply with the Court’s order and to also allow
17 Amazon sufficient time to review the PersonalWeb document production and prepare its Fees
18 Submission in light of that production;

19 WHEREAS, PersonalWeb expects to complete production by January 20, 2023 in
20 compliance with the Court’s order;

21 NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED amongst the Parties
22 that, assuming that, that the deadline for Amazon to file its Fees Submission before this Court be
23 extended from January 15, 2023 until March 3, 2023; any PersonalWeb opposition brief is due by
24 March 17, 2023; and any Amazon reply brief is due by March 24, 2023.
