1 Having considered the Joint Submission Regarding Amazon’s Motion to Compel Production
2 of Documents That the PersonalWeb Investors Have Improperly Withheld as Privileged, and finding
3 good cause therefor, the Motion is GRANTED.

4 **IT IS HEREBY ORDERED THAT** Brilliant Digital Entertainment, Inc. (“BDE”) and
5 Monto Holdings Pty Ltd. (“Monto”) have waived privilege over the following documents listed in
