1 WHEREAS, Plaintiff PersonalWeb Technologies, LLC (“PersonalWeb”) has accused
2 Defendants Amazon.com, Inc., Amazon Web Services, Inc., and Twitch Interactive, Inc.
3 (collectively, “Amazon”) (collectively, PersonalWeb and Amazon may be referred to as “Parties”)
4 of infringing, inter alia, U.S. Patent Nos. 7,802,310 and 6,928,442;

5 WHEREAS, on May 23, 2023, Amazon filed a request for further supplemental fees
6 (including for fees pursuant to 35 U.S.C. § 285; the appeal fees denied without prejudice by the
7 Court in its April 19, 2021 Order (Dkt. 656); and fees that Amazon has incurred since) (“Fees
8 Submission”) (Dkt. 880);

9 WHEREAS, the Court has scheduled the Fees Submission for a hearing on October 5, 2023;

10 WHEREAS, PersonalWeb desires additional time to oppose the Fees Submission, and
11 Amazon does not object to giving PersonalWeb such additional time;

12 WHEREAS, Amazon desires additional time to file its reply in support of its Fees
13 Submission, and PersonalWeb does not object to giving Amazon such additional time;

14 NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED amongst the Parties
15 that that the deadline for PersonalWeb to file any opposition to Amazon’s Fees Submission before
16 this Court be extended from June 6, 2023 until July 14, 2023; and the deadline for Amazon to file
17 any reply in support of its Fees Submission before this Court be extended from June 13, 2023 until
18 September 15, 2023.
