8 Submission") (Dkt. 880);

WHEREAS, the Court has scheduled the Fees Submission for a hearing on October 5, 2023;
 WHEREAS, PersonalWeb desires additional time to oppose the Fees Submission, and
 Amazon does not object to giving PersonalWeb such additional time;

WHEREAS, Amazon desires additional time to file its reply in support of its Fees
Submission, and PersonalWeb does not object to giving Amazon such additional time;

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED amongst the Parties
that that the deadline for PersonalWeb to file any opposition to Amazon's Fees Submission before
this Court be extended from June 6, 2023 until July 14, 2023; and the deadline for Amazon to file
any reply in support of its Fees Submission before this Court be extended from June 13, 2023 until
September 15, 2023.
