1 I, Philip Ou, hereby declare as follows:

2 1. I am a partner with the law firm Paul Hastings LLP, counsel for the Plaintiff  
3 Applied Materials, Inc. (“Applied”) in the above captioned matter. I have personal knowledge of  
4 the facts contained in the declaration and, if called upon to do so, I could and would testify  
5 competently to the matters set forth herein.

6 2. I submit this declaration in support of Applied’s Motion To Shorten Time For An  
7 Earlier Hearing Or For Determination On The Papers On Applied’s Motion To Strike.

8 3. On February 18, 2022 counsel for Applied confirmed with counsel for Demaray
