Demaray files this notice of withdrawal of its Discovery Letter Brief to Amend Demaray LLC's Answer to Add Affirmative Counterclaims for Infringement at Docket 127, for the reasons described below.

On February 8, 2022, Applied opposed Demaray's letter brief (on both procedural and substantive grounds), Dkt. 128, and subsequently filed a motion to strike Demaray's letter brief on Thursday March 2, 2022, Dkt. 130. In these papers, Applied "requests the Court decline to address Demaray's letter brief and instruct Demaray to file a noticed motion in compliance with this Court's Local Rules." Dkt. 128.

While Demaray believes that its letter brief was procedurally proper, Demaray filed a motion to amend on March 9, 2022. Dkt. 133. In those papers, Demaray stated that "to avoid burdening the Court with deciding Applied's motion to strike, concurrently with the filing of the instant brief, Demaray withdraws its letter brief in favor of this motion to amend."

Thus, Demaray files this notice of withdrawal.
