1 Pursuant to L.R. 6-1(a), Plaintiff Google LLC (“Plaintiff”) and Defendants AGIS Holdings,
 2 Inc., Advanced Ground Information Systems, Inc., and AGIS Software Development LLC
 3 (collectively, the “Defendants”) hereby stipulate that Plaintiff’s deadline to file its Opposition brief
 4 to Defendants’ Motion To Dismiss, Or In The Alternative, To Transfer To The Eastern District of
 5 Texas (ECF No. 44) shall be extended by 18 days from December 11, 2023, up to and including
