1. Failure to serve all defendants or obtain an order(s) for publication of the summons within 180 days of filing the complaint. CRC, rule 3.740(d).
2. Failure to obtain a default judgment within 360 days of filing the complaint, after proof of service of complaint is filed or service by publication is made and a defendant has not filed a responsive pleading. CRC, rule 3.740(f).
3. Failure to file a Request for Case Management Conference form with the Court indicating that the case is ready for trial setting, after a defendant has filed a responsive pleading. CRC, rule 3.740 (c)(2).

**IMPORTANT: If the case is dismissed, settled, or a default judgment is entered at least 10 court days prior to the order to show cause hearing, then the order to show cause hearing will be taken off calendar. CRC, rule 3.740(f).**

**The Court may in its discretion dismiss an action for delay in prosecution pursuant to this article on its own motion or on motion of the defendant if to do so appears to the Court appropriate under the circumstances of the case. CCP §583.410(a).**
