

19 On January 8, 2019, this Court issued its tentative ruling on the Petition to
20 Compel Arbitration and Stay Court Proceedings brought by Defendant ANDREA A.
21 WOLOSCHUK, individually and doing business as MARIPOSA GARDENING AND DESIGN.

22 The tentative ruling stated:

23 Defendant Woloschuk's motion to compel arbitration and stay court proceedings is
24 GRANTED. The present proceedings are hereby STAYED pending completion of the
25 arbitration.

26 Defendant Woloschuk has established the existence of an arbitration agreement between
27 the parties and there is no basis to deny enforcement of the agreement under CCP §
28 1281.2.
