1. Subsequent to the filing of this action, Defendant ARRIS Group, Inc. (“ARRIS Group”) merged into another company, Ruckus Wireless, Inc. Accordingly, ARRIS Group no longer exists as an independent entity.
2. ARRIS Solutions, Inc. (“ARRIS Solutions”), formerly a subsidiary of ARRIS Group, is the entity responsible for any making, using, selling, offering for sale, and/or importing into the United States that may occur, if at all, with respect to the ARRIS products that Plaintiff Realtime Adaptive Streaming, LLC accuses of infringement in this case.
