**STIPULATED EXTENSION OF TIME FOR DEFENDANTS'
RESPONSE TO SECOND AMENDED COMPLAINT**

Pursuant to D.C.COLO.LCivR 6.1, Plaintiff Realtime Adaptive Streaming LLC and Defendants ARRIS Group, L.L.C., DISH Network, L.L.C. and EchoStar Technologies, L.L.C. through their undersigned counsel, stipulate to an extension of time for Defendants' response to Plaintiff's Second Amended Complaint.
