### **JOINT STATUS REPORT**

In accordance with the Court's instruction at the July 29, 2021 hearing, the parties conferred regarding which motions are mooted and which motions still require judicial resolution in view of the expected settlement in *Arendi S.A.R.L. v. Apple Inc.*, C.A. No. 12-1596-LPS ("the Apple Lawsuit"). In short, the parties believe judicial resolution is still required for (1) any motions jointly filed by Apple and one or more of the other defendants (e.g., the *Daubert* motions



directed to Weinstein and Marais); and (2) any motion filed by another defendant even though it may raise issues that overlap with issues in a motion filed by Apple. The remaining defendants request that the Court consider argument presented by Apple's counsel in resolving the defendants' motions for summary judgment of non-infringement.

On the other hand, a motion filed by Plaintiff Arendi S.A.R.L. ("Arendi") only against Apple and a motion filed by Apple that was not joined by other defendants no longer requires judicial resolution.

Below, the parties identify the motions filed in the Apple action, whether those motions are mooted or the other actions in which the same motion is pending.
