INSPIRED BY THE FAN FAVORITE "PICK TEN" SYSTEM, CREATE-A-CLASS GIVES PLAYERS MORE OPTIONS THAN EVER BEFORE TO CUSTOMIZE LOADOUTS FOR ALL STYLES OF PLAY. IN ADDITION TO SELECTING ALL WEAPONS, PERKS AND ATTACHMENTS TO CREATE A LOADOUT, SCORESTREAKS HAVE BEEN ADDED TO THE MIX FOR AN EXTRA LAYER OF PERSONALIZATION – AND THREE EXTRA SLOTS.

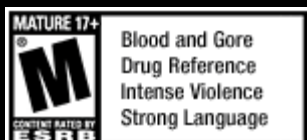
