NOTICE OF SUBSEQUENT AUTHORITY

Pursuant to D. Del. LR 7.1.2(b), Defendant OmniVision Technologies, Inc. (“OmniVision”) hereby provides this notice of subsequent authority relating to OmniVision’s Motion to Transfer Venue to the Northern District of California (D.I. 10). Attached hereto as Exhibit A is a decision recently issued by Judge Andrews in *Godo Kaisha IP Bridge 1 v. OmniVision Technologies, Inc.*, C.A. No. 16-975 (D.I. 27), granting OmniVision’s motion to transfer venue to the Northern District of California filed in that case. OmniVision respectfully suggests that Judge Andrews’ decision rests on the same facts present in this action, and will be useful to the Court’s resolution of the motion at bar. Specifically, the parties in that case and in this action are the same, and the allegations giving rise to Plaintiff Godo Kaisha IP Bridge 1’s claims of infringement are much the same in both cases. Thus, the considerations for transfer of venue under 28 U.S.C 1404(a) in that case and in this action are all but identical. Moreover, there will now be a co-pending action moving forward in the Northern District of California.
