[PROPOSED] ORDER

WHEREAS, the Court having considered Plaintiff Acceleration Bay LLC’s (“Acceleration Bay”) Motion for Leave to Amend its Preliminary Election of Asserted Claims and the related briefing;

IT IS HEREBY ORDERED this ___ day of _____, 2017, that Acceleration Bay’s Motion is hereby GRANTED.

(1) Within three (3) days, Acceleration Bay shall serve its Amended Preliminary Election of Asserted Claims on Defendants (a) withdrawing its election of claims found unpatentable in *inter partes* review proceedings; (b) adding claim 12 of U.S. Patent No. 6,701,344 and (c) adding claim 10 of U.S. Patent No. 6,829,634;

(2) Within ten (10) days, Acceleration Bay shall serve infringement contentions for claim 12 of U.S. Patent No. 6,701,344 and claim 10 of U.S. Patent No. 6,829,634; and

(3) Within thirty one (31) days, Defendants shall serve invalidity contentions for claim 12 of U.S. Patent No. 6,701,344 and claim 10 of U.S. Patent No. 6,829,634. Failure to serve invalidity contentions within that time period shall be deemed an admission that the claims are valid.
