Pursuant to the Court’s January 21, 2020 order staying this Action (D.I. 18), the parties write to inform the Court that Blackboard Inc.’s motion to transfer venue of *Uniloc 2017 LLC v. Blackboard Inc.*, No. 17-cv-753-LY (W.D. Tex.) was granted on May 15, 2020. That case has now been docketed in this district, with case number, 1:20-cv-00665, and has been assigned to Chief Judge Stark. Uniloc 2017 LLC has filed in that action a notice that the action is related to this one.

The current stay in this case was predicated on the disposition of Blackboard’s motion to transfer the Western District of Texas action. As such, the parties agree that the stay should be lifted. The
