PLEASE TAKE FURTHER NOTICE that if the deposition(s) is by remote audio-video conference, it will be recorded by stenographic and audiovisual means, and may utilize instant visual display of the testimony, and a paperless virtual display platform. Both the court reporter and digital reporter are authorized to administer the oath and serve as the deposition officer in the State of Delaware. Take note that the deposition officer may also be remote and out of the presence of the deponent via video teleconferencing or telephonically for the purposes of providing the oath/affirmation to the deponent and capturing the proceeding via one of the options above.
