The above-referenced case having been formally charged by the District Attorney's Office, the following calendar dates and deadlines shall apply:

**Future Calendar Dates**


- Jail Arraignment & Final Plea held in Courtroom 3 at Jail @9:00a.m. on **JULY 9 2019.** (Date)
- Bond Arraignment & Final Plea held in Courtroom 1C @ 9:00a.m. on **JULY 8, 2019.** (Date)
- Pre Trial Conference held in Courtroom 1D @ 9:00a.m. on **JULY 18, 2019.** (Date)
- Trial (Two weeks) held in Courtroom 1D @ 9:00a.m. beginning **JULY 22, 2019.** (Date)

**Deadlines**

- All Defendants are presumed to have **OPTED IN** to Discovery unless they specifically **OPT OUT** in writing on or before the All Purpose Hearing.
- The State shall provide full Discovery to the Defense three (3) days prior to Arraignment (excluding weekends and holidays). Discovery includes but is not limited to video(s), police reports, warrants, search warrants and accompanying affidavits, dash cam, 911 reports and CAD reports, fingerprint reports, fingerprint cards, DNA reports, statements of witness(s), statement(s) of Defendant, bank statements, credit card statements, bill of sale, insurance documentation, contracts and all other relevant information which should be known to the State. The State must diligently pursue crime lab evidence/reports and shall turn that evidence over to the Defense as soon as it is available. The failure to comply with these Discovery deadlines may result in exclusion of the evidence.
- The State shall provide the Defense with a "best offer" in writing on or before Arraignment & Final Plea.
- State motions are due by 5p.m. the Monday prior to Pre Trial Conference or the following business day if that Monday falls on a holiday.
- Defense shall file all supplemental motions by 5p.m. the Monday prior to the Pre Trial Conference or the following business day if that Monday falls on a holiday.

**Defendant shall maintain a current address on file with the Clerk. Failure to report to the above Calendars shall result in the forfeiture of any bond which may have been set.**
