Plaintiff in the above-entitled matter has an unpaid judgment against the judgment defendant, JUAN G GONZALEZ, on which there is now due the sum of \$805.64, plus post judgment interest of \$859.28, costs of \$116.00, for a total unpaid judgment of \$1,780.92.

The garnishee defendant PANASONIC CORPORATION OF NORTH AMERICA is now ordered to answer under oath the interrogatories set forth below or attached in writing on or before 11/05/2021, or, at your option, appear in Court and answer the interrogatories in person at the hearing. Any claim or defense to the proceedings supplemental or garnishment order must be presented at the time and place of the hearing specified herein.

It is further ordered that garnishee defendant, a depository financial institution, is to place a 90-day hold on any deposit accounts in which the judgment defendant, JUAN G GONZALEZ, has an interest, either individually or jointly with another person, pursuant to IC 28-9-4-2, upon receipt of the documents, payment, and process required under subdivisions (1) through (5) of IC 28-9-3-4(b).

To the judgment defendant, JUAN G GONZALEZ, you are ordered to contact Plaintiff's counsel's office by telephone at 11:00 AM on 11/19/2021 for a telephonic hearing. If you the Defendant, believe that you are entitled to a reduction of the Garnishment Order due to financial hardship, you may file a written request to reduce the amount of the garnishment. **If you DO NOT contest the garnishment, attendance to the telephonic hearing is not necessary.**

Please note, that if you, the Defendant, believe that you are entitled to an exemption because the funds in the account at issue include stimulus funds, you may file a written request for an immediate hearing to determine if funds are attributable to a stimulus payment.


