I have set the target date for this investigation at Wednesday, October 26, 2022, which is seventeen months from the date that the Notice of Investigation was published in the Federal Register. *See* Order No. 4. The final initial determination is therefore due by Monday, June 27, 2022. *Id.* 

The evidentiary hearing will be held Monday, March 28, 2022 through Friday, April 1, 2022. A two-day *Markman* hearing will be held on Tuesday, October 26, 2021 and Wednesday, October 27, 2021. The parties should submit a proposed procedural schedule for the investigation no later than close of business on Thursday, June 24, 2021. The proposed schedule should take each of the above dates into consideration and include dates for each of the events set forth in Ground Rule 2 to the extent they are appropriate for this investigation.

The parties should make good faith efforts to agree to a procedural schedule. It is expected that the parties should be able to submit a joint proposal on this matter.
