**ORDER NO. 27: DENYING AS MOOT COMPLAINANTS' MOTION TO DECLASSIFY THE DEPOSITION TRANSCRIPT AND CERTAIN DEPOSITION EXHIBITS OF MR. SORIN DINU CONCERNING THE LOCATION OF GOOGLE'S WITNESSES IN LONDON, ENGLAND**

(July 25, 2023)

On July 12, 2023, Complainants Advanced Ground Information Systems, Inc. and AGIS Software Development LLC ("AGIS") filed a motion (Mot. 1347-017) seeking to declassify portions of the deposition transcript of Sorin Dinu, a witness for Respondent Google LLC, and certain deposition exhibits, in part or in their entirety. On July 24, 2023, AGIS filed a notice of withdrawal of its motion. Accordingly, AGIS's motion is DENIED AS MOOT. Further, for good cause shown, AGIS's unopposed request for waiver of Ground Rule 1.3.1<sup>1</sup> as to its motion to declassify is GRANTED. *Cf.* 19 C.F.R. 210.4(f)(7)(ii)(B).
