**JOINT STIPULATION OF DISMISSAL WITH PREJUDICE**

Pursuant to Fed. R. Civ. P. 41(a)(1)(A)(ii), Plaintiff Aplx IP Holdings Corporation (“Aplx”) and Defendants Sony Computer Entertainment Inc. The Parties further jointly stipulate that each Party shall bear its own costs, fees and expenses in connection with this action.
